

# Official Ballot and Referendum

Nonpartisan Office April 3, 2018

**Notice to Voters:** If you are voting on Election Day, your ballot must be initiated by two election inspectors. If you are voting absentee, your ballot must be initiated by the municipal clerk or deputy clerk. Your ballot may not be counted without initials. (See end of ballot for initials.)

**IMPORTANT** - It is recommended to use an official ballot marking pen available at your polling place or a #2 pencil.

### Instructions to Voters

If you make a mistake on your ballot or have a question, ask an election inspector for help. (Absentee voters: Contact your municipal clerk.)

To vote for a name on the ballot, complete the arrow next to the name like this  $\leftarrow$ .

To vote for a name that is not on the ballot, write the name on the line marked "write-in," and complete the arrow next to the name like this  $\leftarrow$ .
